Disclosures, Definitions, and Notes

- **Management Fees** are paid to the investment adviser of the fund.

- **12(b)-1 Fees** are the annual distribution and marketing fees paid by the fund as described in the fund's prospectus. These are paid to VALIC or an affiliate for marketing and distribution services. Participants receive an offsetting reduction in the separate account fee as applicable to amounts allocated to that fund option.
- **Other Expenses** include expenses related to administrative and shareholder services provided to the fund, such as accounting, audit, compliance, custody, legal and other shareholder-related services.
- **Acquired Fund Fees and Expenses** apply to a fund that invests in underlying funds and reflects the relevant portion of the fees for those underlying funds.
- **Total Fund Expenses** before Expense Waivers or Reimbursements equal the sum of Column A through Column D.
- **Expense Waivers or Reimbursements** - Pursuant to an expense limitation agreement, the fund's adviser will waive fees or reimburse expenses as shown in this column. The adviser may recoup previously waived and/or reimbursed expenses for a period of time after such waiver or reimbursement, which recoups are reflected as an addition to the fund's Net Fund Expenses as shown in Column G. Fees are subject to change based on Expense Waivers or Reimbursements.
- **Net Fund Expenses** equal the Total Fund Expenses less Expense Waivers or Reimbursements (Column E less Column F).
- **Net Separate Account Fee** compensates the contract issuer for a combination of guarantees and services, including mortality guarantees, expense guarantees, administration and distribution. This fee also reflects an offsetting reduction for 12(b)-1 fees or, where applicable, for non-12(b)-1 service fees or a portion of the recordkeeping fees received from a fund affiliate.
- **Total Net Variable Account Option Fees** equal the Net Fund Expenses plus the Net Separate Account Fees (Column G plus Column H).
- **Net Compensation Paid to VALIC (and affiliates)** includes the relevant portion of the amounts itemized above plus any additional compensation to VALIC or an affiliate (including SunAmerica Asset Management LLC and other related parties) including compensation for sub-advisory, shareholder, transfer agent, administrative, and recordkeeping services. Where applicable, this compensation ranges from 0.06% to 0.43% per fund and is included in the Net Compensation Paid (Column J).
- The above fund fees are not applicable to the fixed investment options.
